The Pest Control Products Board (PCPB) wishes to bring to the attention of the Public that the following pest control products are unregistered and therefore illegal.

The PCPB Act provides that anyone found selling or distributing these pest control products in any manner is liable for imprisonment for a term not exceeding two years or a fine of Ksh 250,000 or both.

Unregistered pest control products are unsafe and dangerous. The Public is therefore urged to report the sale or distribution of these pest control products to the PCPB offices, Agricultural offices and or to the nearest police station.

HAWKING OF PESTICIDES IN MARKETS AND FARMS

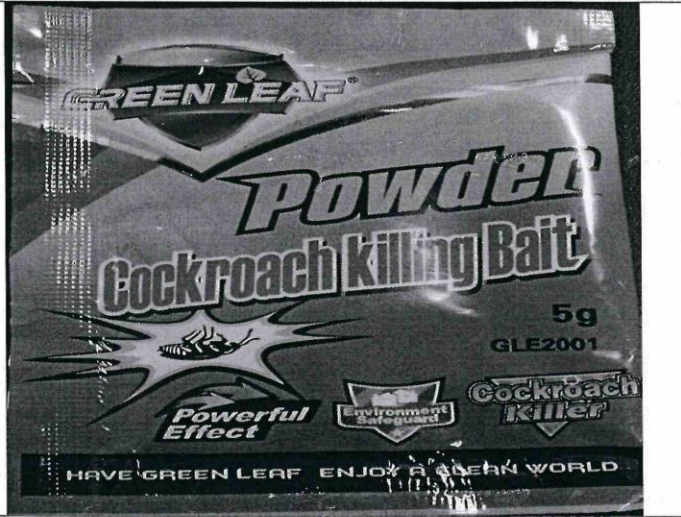

The public is notified that the quality of pesticides sold in this manner cannot be guaranteed and that they pose a risk to themselves and the environment.

Members of the public are therefore advised to procure pesticides from PCPB licensed dealers.

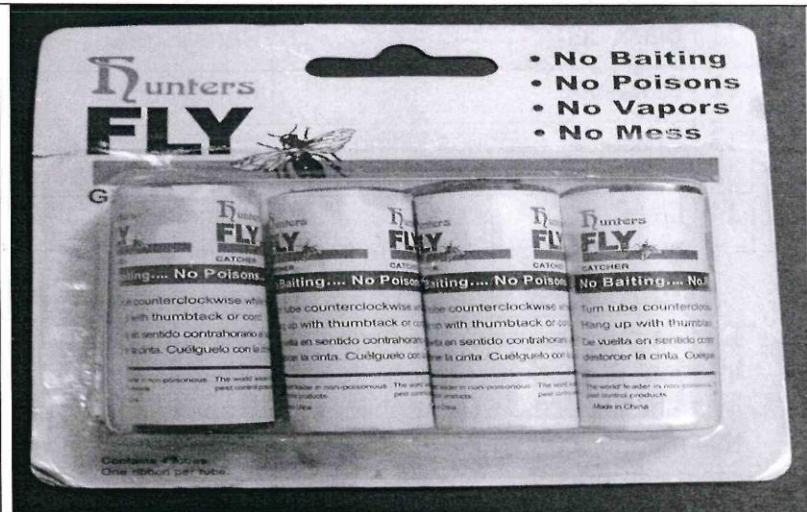
